Our honourable founder was born on 8th December, 1920 in the historical town Faizabad, India. After completing his LL.B. from Canning College, Lucknow, he became a Munsif in the year 1944. In 1974, he was promoted as District Judge. In the year 1976, he was elevated as a Judge in Allahabad High Court Lucknow Bench. After his retirement, he served twice as Lokayukta of Uttar Pradesh from 1983 to 1989.

His decisions in some of the very complicated litigations are and will always remain landmarks in the history of Law. He was a voracious reader and a connoisseur of English, Urdu and Persian literature and poetry. He authored many books on different subjects in addition to his autobiography.

In 1996, Unity Technical Institute Society was established by him with the main objective of providing professional and technical education to all, especially to those belonging to the minority communities and other educationally backward classes.

Thereafter, in the year 1998, Justice Murtaza Husain founded Unity Degree College.

Unity Degree College was the first minority institution of North India. Today, the College is a Post Graduate college, having been upgraded in 2018.

Unity P.G & Law College is his dream child. He often used to say that he loved the College as intensely as he loved his children. He was a saint by all standards who spent the earnings of his lifetime in establishing this institution.

His legacy will carry on through his values, thoughtfulness and compassion for all persons which find manifestation in the deeds of his lifetime.

## We offer the following courses:

### Department of Legal Studies

#### 1. LL.B. (Hons.)

- This course is open to candidates who have passed Intermediate or equivalent (10+2 or 11+1) examination from any recognised Board having secured the given minimum percentage of marks as decided by the University of Lucknow and Bar council of India from time to time.
- General & OBC - Minimum 45% marks.
- SC/ST - Minimum 40% marks.

#### 2. LL.B. (Three Year)

- This course is open to candidates who have graduated from any recognised university in India or abroad with:
- General and OBC - Minimum 45% marks.
- SC/ST - Minimum 40% marks.

### Department of Management

#### 1. B.B.A.

- This course is open to candidates who have passed Intermediate or equivalent examination from any recognised Board with:
- General and OBC - Minimum 50% marks.
- SC/ST - Minimum 45% marks.

### Department of Commerce

#### 2. B.Com.

- Intermediate or equivalent examination with Commerce or Intermediate with Economics or Mathematics as one of the subject of study.
- General and OBC - Minimum 40% marks.
- SC/ST - Minimum 33% marks.

#### 3. M.Com.

- B.Com. or B.Com. (Hons.) from any recognised university with:
- General and OBC - Minimum 45% marks.
- SC/ST - Minimum 40% marks.

or any candidate possessing similar professional qualification with Mathematics & Economics as a subject of study must have percentage as per the University guidelines.

### Department of Education.

#### 1. B.Ed

- This course is open to the candidates who have passed graduation or post graduation examination from any recognised university having secured the given minimum percentage of marks as decided by the University of Lucknow.
- There is no age limit for the course.



## 2. D.EEd. (B.T.C)

- This course is open to candidates who have passed graduation or post graduation examination from any recognised university having secured the given minimum percentage of marks:
- General and OBC - Minimum 50% marks.
- SC/ST - Minimum 45% marks.

Age Limit: 18-35 Yrs. (Relaxation upto 5 yrs. to SC / ST and OBC) and for 15 years of relaxation for PH. candidates

## Department of Humanities.

### 1. B.A.

- Intermediate or equivalent examination from any recognised board with:
- General and OBC - Minimum 40% marks.
- SC/ST - Minimum 33% marks.

The applicants shall be required to produce the following documents in original with a sets of self-attested photocopies at the time of admission:

5. Recent Character Certificate
6. Caste Certificate
8. Transfer Certificate from school / college as well as Migration Certificate from Board / University are required from those students who have passed school/college exam from outside Lucknow.

10. Affidavit ( Gap certificate , if any )
11. Graduation Mark-sheet
12. Graduation Degree

**Please note that at the time of admission original documents will be inspected for verification.**

### Attendance

No student shall be allowed to appear in the final examination if they have not attended a minimum of 75% of the classes held including the moot court exercises, internal examination, viva, tutorials, projects, practice teaching and practicals conducted in the concerned subject.

### **College Fees, Expenses And Refund**

College Fees includes Tuition, D.A. Admission, Library and Reading Room, Laboratory up keep and establishments, Games, Development, Internal Examination, Identity Card, Audio Visual Aids, Student Aid Fees.

### **Fee Structure**

The fee structure of each course will be provided along with the Application Form.

### **Payment of Fees**

All the fees, in CASH or DEMAND DRAFT only (not by cheque), is payable to the Unity P.G & Law College Fee Counter in Accounts Office.

### **Payment of Late Fee and Fine**

If the fees is not paid within one month of the beginning of the semester/year, a late fee of Rs. 10/- per day shall be charged.

### **Withdrawal Rules and Regulations**

Guardians of the respective student must send an application to the Principal with reasons of their intention to withdraw their ward from the college one month prior and may take their Transfer Certificate/Character Certificate in the same session. A student can withdraw after getting a No Dues certificate from each section /unit of the College.

### **Forwarding of University Examination Forms**

The University examination forms will not be forwarded unless the student has paid all dues along with the examination fee to date. When making fee payments, students are required to pay all their fees and other charges, that may be due, together. Admission cards for the University Examination will not be given unless all requisite college fees, fines and other dues have been paid and college material, if any, has been returned.

### **Deposition of Fees**

Payment of fees at the fee counter of accounts office of Unity P.G & Law College, Lucknow is the responsibility of the student. No fee money should be deposited with any member of the College staff.

### **Non-compliance of rules**

The College will not be responsible for any loss owing to non-compliance of the above rules and procedures. Students should preserve all fee receipts which will be required for getting the Examination Admit Card, No Dues Certificate and for confirmation of their payment of fees.



## Fee Refund Policy

Rules for refund of fee on Account of withdrawal/cancellation of admission

S.No.	Reasons for seeking refund	Quantum of fee to be refunded
1.	When a student applies for withdrawal of admission upto 15 July.	60% of total fee deposited by student
2.	When admission is made inadvertently, due to error/omission/commission on the part of the College	Full fee and full examination fee
3.	When cancellation of admission is due to concealment/falsification of facts, submission of false/fake certificates(s), providing misleading information by the student or for any error/mistake on the part of the student	No fee will be refunded
4.	In case of a student leaving the college before completing the course.	No fee will be refunded
5.	If a student provisionally admitted to a course on declaration of the result of his qualifying examination /compartmental examination becomes ineligible for admission and his/her admission is cancelled.	Full fee after deduction of Rs. 1000/- provided that he/she applies for refund in the same/ Financial Year.
6.	When a student has been allowed to change the course of study in the same college	After adjustment of fees already the student will be required to pay remaining amount due as prescribed for the new course. In case the student paid in the previous course more than the amount due for the second course, the excess amount will be adjusted towards further month fees.

### Refund of caution money

Refund of caution money is to be made after final university examinations including practical of the final session and after making deductions for loss of books, breakage etc. Refund of the caution money will be done producing original fee receipt for the same.

Note: Caution money should be collected within three years,. Unclaimed caution money will automatically lapse after three years



## Discipline

Students are required to maintain good conduct and discipline. Violation of College rules and regulations makes a student liable for disciplinary action. Internal discipline is maintained by the Proctorial Board. All students must abide by the rules and regulations of the college and attend classes regularly. Admission of any candidate will stand cancelled if He/ she fails to attend classes within the first 14 days from the date of the beginning of the classes. As per the University rules, a student must have a minimum of 75% attendance in each class. In case of absence, students are required to submit an application, duly signed by a parent/guardian.

In case of absence owing to illness, students are required to submit an application duly signed by their parent/guardian along with a medical certificate. Students can leave the College campus only after 12:30 p.m. Day scholars who have to leave College campus in case of emergency before 12.30 p.m. can do so only by obtaining permission in writing from the HOD/ Principal /Chief Proctor. A letter from their parents/guardian requesting the same must be submitted.

Tobacco chewing and smoking in the college campus are strictly prohibited.

Students are not permitted to bring valuable items to the College. The College will not be responsible for the loss or theft of such items

Silence is to be maintained in the corridors during class hours

Students are not permitted to use mobile phones in the corridors, classrooms and library.

Students must take proper care of the College property, furniture and premises and not cause any damage to or tamper with College property, furniture and fittings.

Students may park their bicycles, scooters or motorcycles in the shed provided for this purpose. No vehicle should be parked in any other part of the College premises.

**Ragging is a legal offence. Any student reported for being involved in or standing witness to ragging will be immediately expelled from the College and Hostel.**

### Identity Card

Every student of the college is issued an Identity Card which he/she is expected to carry with him/her at all times. He / She will have to produce it whenever demanded. Students should collect their new Identity Cards at the beginning of the academic session. In case of loss of Identity Card, a duplicate card can be issued from the office on payment of Rs. 100/-.

### Uniform

The college Uniform is compulsory for all students. Strict uniformity is to be maintained, students are advised to buy their uniform from the college to avoid variation of shades.

Students are not permitted to enter the college campus without proper and complete uniform.

The uniform details are as follows:

### Summer

1. Boys: Steel grey pant, white shirt, college tie, college belt, dark brown/ black shoes and black socks.
2. Girls: White salwar, steel grey kurta, white dupatta, dark brown/ black shoes and black socks.

### Winter

1. Boys: Steel grey pant, white shirt, college tie, college belt, dark brown/ black shoes and black socks and grey sweater/grey blazer
2. Girls: White salwar, steel grey kurta, white dupatta, dark brown/ black shoes and black socks, black grey sweater/grey blazer.

**Note : Law Students are required to wear Black Pants instead of steel grey pants. Wearing of steel grey saree will be compulsory for teaching practice for female B.Ed. students.**
