• Preamble and its Significance

What is constitution?

- 1. The constitution is a document that provides an edifice of principles and framework for the functions of the organs of the government of a state and it declares the principles governing the operation of those organs.
- 2. The Constitution sets out the matrix to regulate the different institutions of the Government within the Nation and outside the Nation.
- 3. Constitution is a codification of those basic rules which can not be disregarded by the Government and by any authority of the Government.
- 4. The constitution is a floor to check and balance the adopted procedures, by the authorities of Government.
- The constitution is an erection of Fundamental Rights, Directive Principles, Fundamental Duties, and Structure of Institutions of Government at the Central and State levels.

What is Preamble?

- The Preamble of the Constitution is a collection of 63 words which is an ideal piece of structure that lays down the pillars of the Country.
- The Preamble of the Constitution is an aspiration and natural ideal of the people of India.
- The Preamble is a sort of introduction to the statute and many times very helpful to understand the policy and intention of the Government at both levels.

In the case of I.C Golak Nath V. State of Punjab AIR 1967 SC 1643

C.J. Subba Rao said that the Preamble to an Act sets out the main objectives that the legislation is intended to achieve.

The Preamble embodies in a solemn form all the ideals and aspirations for which the country has struggled so far.

✤ PREAMBLE OF THE INDIAN CONSTITUTION

- WE, THE PEOPLE OF INDIA, having solemnly resolved to constitute India into a SOVEREIGN SOCIALIST SECULAR DEMOCRATIC REPUBLIC and to secure to all its citizens:
- JUSTICE, social, economic and political;
- LIBERTY of thought, expression, belief, faith, and worship;
- EQUALITY of status and of opportunity;

- and to promote among them all
- FRATERNITY assuring the dignity of the individual and the unity and integrity of the Nation;
- IN OUR CONSTITUENT ASSEMBLY this twenty-sixth day of November 1949, do HEREBY ADOPT, ENACT AND GIVE TO OURSELVES THIS CONSTITUTION

Constitutional identity

The preamble defines the essential identity of the Indian Constitution. It

sets the tone for the entire legal framework and for the subsequent articles and provisions in the Constitution.

International influence

The use of the words such as 'Justice, 'Liberty, and 'Equality in the preamble, reflects the influence of international ideals and principles. It highlights India's commitment to global values of human rights, social justice, and equality.

Reflection of historical struggles

The preamble reflects the sacrifices made and the struggles faced by the Indian people in their fight for an independent India and Justice. It pays homage to the freedom fighters and the principles for which they fought.
